- 1. A credit card number is required to secure reservations
- 2. Your credit card will be billed 100% to the credit card on file in the event of no shows, cancellations, and/or changes within 48 hours of scheduled services
- 3. No changes will be allowed less than 48 hours prior to event and/ or final confirmation has occurred.
- 4. We request all groups check-in 15 minutes prior to your appointment time.
- 5. We are not responsible for delays due to weather, traffic, construction, trains, directions or any other instances beyond our control
- **6.** If you are running late for an appointment, please call us immediately and we will do our best to accommodate your service. However, the service length may have to be adjusted to fit within our schedule. The group will still be responsible for the full priced service, as contracted.
- 7. All parties are required to pay a 50% deposit prior to confirming any appointment times. No appointments for any services will be made until signed contract and deposit are received. 50% deposit will become nonrefundable within 2 weeks prior to scheduled event.
